



San Joaquin County Bar Association 2010 Law Day Poster Contest Rules: Theme: Law in the 21st Century: Enduring Traditions, Emerging Challenges

Please review the rules below closely before contacting the San Joaquin County Bar Association with eligibility questions.

- **Prizes:** The prizes are as follows: **First Place — \$250; Second Place — \$150; Third Place — \$100.**
NOTE: The First Place winner will be framed and put on display at the new Family Law Court located at 540 E. Main Street in Stockton and will be used as the cover of the Bar Association's publication "Across the Bar."
- The Poster contest is designed for students who are full-time eighth (8th) grade students in **San Joaquin County**.
- The eligibility of submissions will be confirmed by the Program Committee of the San Joaquin County Bar Association, who will judge the entries, prior to the awarding of prizes.
- **Deadline for entries is Friday, April 30, 2010.**
- Posters must be no larger than 22" x 28" on poster board. There are no minimum size requirements. Posters are not limited to drawings. Paintings, collages and photographs will also be accepted, but must be the original artwork of the student.
- Posters may be submitted via regular mail (postmarked by Friday, April 30, 2010) to the address below.
- **The Cover Sheet serves as your application form for the contest.**
- Applicants **must** include the following: 1) name of their school; 2) teacher; and 3) contact information (mailing address, email address, and phone number) on a cover page attached to the essay.
NOTE: If the student is home schooled, they must include the name of their parent or guardian and all contact information.
- The poster can be sent via regular mail to the address below or hand delivered to the Bar Association offices below.
- Posters submitted will not be returned.
